Privacy Online

Our website, www.towersquare.com, is a great way for current and potential customers and registered representatives to find out more about Tower Square's products and services. Rest assured that when you visit our site we will not try to gather any personal identifiable information from you without you knowing it. The following summarizes the extent to which we gather and use information obtained through our website:

- **Cookies** – Cookies are elements of data that a website can send to your browser when you link to that website. Like most commercial website owners, we may use cookies on the public portion of our website to identify you as a user of the Tower Square site and thus provide you information specific to this website. These cookies do not gather or store personally identifiable information about you. On the password-protected Registered Representatives' portion of the website we may use cookies to identify individual users and provide user-specific information to our Registered Representatives. Our collection and use of this limited information will strictly adhere to the terms of our Privacy Promise at all times.
- **Statistical Domain and Access Data** – Please note that when you visit our website, no personally identifiable information about you, such as your e-mail address, will be automatically collected by us. In fact, unless you choose otherwise, the only information we may collect from your visits is some information regarding the domain from which you are connecting to our website (e.g., msn.com if you are connecting from Microsoft Network, or aol.com if you are connecting from AOL) and the pages you view while on our site. This information is collected solely for statistical purposes and is not used to identify individuals.
- **E-mail** – In some cases, you may actually choose to provide us with your e-mail address or other personal information such as your address or phone number. For example, if you send us an e-mail for any reason, you are by default providing us with an e-mail address.

In most instances, your inquiry will be forwarded to a Tower Square representative who is licensed in your area for a response. This is necessary to help ensure that your specific inquiry is answered in accordance with the laws and regulations in your state of residence. E-mail addresses or other information you voluntarily provide while visiting our website are used solely for the purpose of responding to your questions and concerns, and will only be shared with others in accordance with applicable laws and regulations, which in some instances may require sharing such correspondence with our legal and compliance departments or with state and/or federal regulators.
